Budget Programs

Mountain Petroleum would like to take this time to thank you for your patronage. Please note, during these hard times, we find it necessary to change our procedures. Prior to delivery, all prior charges must be paid in full unless you are on either Plan A or Plan B. The advantage to you being on a pre-pay plan or budget plan is you will know your monthly expenses versus having to pay in full for each delivery. In addition, during this time of unforeseen high prices, we will be processing statements on the 1st and 15th of each month.

PLAN A: PRE- PAY PROGRAM

This program gives you the opportunity to pre-pay for your fuel in advance at a floating price, which will be \$.38 per gallon less than the daily charge price, at each delivery date. ***Please note after the amount for which you have pre-paid is used up, or the budget period has expired on May 31st of each year, consequent deliveries will be charged at the regular price.***

#2 Fuel Oil, Propane, Kerosene (Min. 600 gal.)

PLAN B: BUDGET PROGRAM -

This is an eleven (11) month budget plan which begins in July. With this plan, you will be charged \$.33 per gallon less than the daily charge price, at each delivery date. ***Please note after the amount for which you have budgeted is used up, or the budget period has expired on May 31st of each year, consequent deliveries will be charged at the regular price.***

#2 Fuel Oil, Propane, Kerosene (Min. 400 gal.)

PLAN C: PRE-PAY FIXED PRICE ON PROPANE

This program gives you the opportunity to lock the price in for the season.

Propane (Min. 700 gal or customer owned tank)

Payment Plans begin **July 1, 2026**. We request that your choice of budget programs be made no later than **July 1st, 2026**. Pre-payment plans must be paid in full by **July 1**.

Call NOW! These plans will not be available after July 1. **Market conditions could cause enrollment closure at any time without notice. These prices will be void if America's oil supply is interrupted by an act of war, terrorism, or shortage of oil supply. PLEASE BE ADVISED: - Budget prices are only in effect July 1st – May 31st. All deliveries during the off-budget period will be charged regular prices.**

Plan A Pre-Pay Program or Plan B Budget Program

FOR HEATING SEASON 2026 – 2027

This contract must be returned if you choose to participate in a specific plan.

This agreement is by and between MOUNTAIN PETROLEUM (referred to in the rest of this agreement as the “company”) and the customer (referred to in the rest of this agreement as the “consumer”).

Both the company and the consumer would like to take advantage of the benefits of the Pre-Pay Program or the Budget Program. **This agreement is being drawn up as an assurance that the company will provide a certain amount of fuel for the consumer and that the consumer will receive a certain amount of fuel.**

1. **FOR THE HEATING SEASON JULY 1, 2026, TO MAY 31st, 2027, THE COMPANY AGREES TO DELIVER FUEL OIL, KEROSENE, OR PROPANE TO THE CONSUMER.**
2. The consumer agrees to pay the company the agreed upon price in full, on or before July 1, 2026, if doing the Pre-Pay Plan or paying 11 monthly payments starting on July 1, 2026, if doing the Budget Program. If the consumer has a credit balance with the company as of June 1, 2026, the balance will be applied toward next year's program. This credit balance is “dollar” credit, not “gallon” credit. **NO REFUNDS WILL BE ISSUED.**

IF USING A CREDIT CARD, PLEASE BE ADVISED WE DEEM IT NECESSARY TO CHARGE A 3% SURCHARGE.

3. Any fuel needed by the consumer more than the pre-buy or budget amount will be priced according to the company's price schedule in effect at the time of delivery.

4. If the consumer does not need the full amount of fuel, the “dollar” credit balance will be credited toward the agreement for the next heating season if such an agreement is offered by the company at that time. **No refunds will be issued. If, for reasons beyond control, the consumer no longer needs fuel and the consumer has a credit balance, a refund will be issued but a 10% fee will be taken from the existing credit balance.**
5. The company cannot fulfill its obligations under this agreement if the company does not have access to the consumer’s tank or pipes. This agreement is expressly conditioned upon the consumer keeping tank, fill pipes, and driveway accessible always for safe delivery. If the consumer falls behind on payments, the company will remove the consumer from the program and deliveries will be discontinued. If collection action is needed to collect any debt owed to the company, any fees will be the responsibility of the consumer.
6. The company shall not be obligated to make deliveries to the consumer when supplies or facilities of production, manufacturing, transportation, distribution, or delivery contemplated by the company are interrupted or unavailable by reason of any enemies, sabotage, strikes, lockout, labor or employment difficulties, fire, act of God, accident, or breakdowns, whether or not preventable, or any cause beyond the company’s control.
7. The consumer acknowledges that the price of heating fuels will fluctuate during the time when the company offers pre-buy/budget agreements to its customers. The consumer acknowledges that, because of this fluctuation, the price the consumer agrees to pay for the pre-buy/ budget amount may be different from the price agreed to by other customers who sign the agreement before or after the date of this agreement.
8. If you are away for any length of time or this is a second home, it is our recommendation that you ask a friend or neighbor to check your home daily. We are not responsible for a customer’s home that experiences a freeze or a run-out.

This agreement is being drawn up as an assurance that the company will provide a certain amount of fuel to the consumer and that the consumer is purchasing a certain amount of fuel. By signing this agreement, the consumer understands and agrees to the conditions in this and all other company policies.
